会议背景：

当今世界百年变局加速演进，世纪疫情延宕反复，乌克兰局势牵动全球，传统安全与非传统安全威胁相互叠加，国际形势更加复杂动荡。全球安全问题凸显并呈泛化趋势。大国博弈、集团对抗不断升级，霸权主义、强权政治威胁上升，安全问题的联动性、跨国性、多样性更加突出，新的脆弱点、贫困带、动荡源不断出现，世界安全形势更加复杂。站在时代的十字路口，各国都在探索应对之道，人类需要作出正确抉择。习近平总书记在博鳌亚洲论坛 2022 年年会开幕式上发表题为《携手迎接挑战 合作开创未来》的主旨演讲，深刻剖析当今世界面临的安全挑战，从人类前途命运出发郑重提出全球安全倡议，为破解全球安全治理难题贡献了中国方案。

在此背景下，本分论坛拟设四个子论坛：1.全球安全治理：发展与安全的关系；2.全球安全治理：全球维度的思考；3.全球安全治理：地区治理的实践；4.全球安全治理：各国的安全政策；邀请国内外知名大学和智库的一流专家学者和部分青年学者聚集一堂，旨在搭建学术平台，促进观点交流，深入探讨全球安全治理面临的挑战与应对之策。

1. 陈沐阳（CHEN Muyang）

北京大学国际关系学院（国际组织与国际公共政策系）助理教授。北京大学、日本早稻田大学学士（双学位项目），美国加州大学伯克利分校硕士，美国华盛顿大学博士。曾在美国波士顿大学全球发展政策中心、日本政策研究大学院大学担任访问研究员。主要研究领域为国际发展、发展融资、全球发展秩序、基础设施投融资、援助与出口信贷、政府市场关系等。曾在 *European Journal of International Relations*, *World Development*, *Studies in Comparative International Development*, *Development Policy Review*, *New Political Economy*, *China International Strategy Review*, 《美国研究》、《日本学刊》、《海外投资与出口信贷》等中英文期刊发表论文。主持国家社会科学基金青年项目《中国崛起与国际发展秩序的变革》。



Muyang Chen is an Assistant Professor at Peking University's School of International Studies. Her research lies at the intersection of political economy, international development, and international relations, focusing on the role of the state in development and addressing the question of how China's overseas development finance affects global order. She also studies the role of public financial agencies in facilitating development assistance, export finance, and industrialization.

Her work has appeared in the *European Journal of International Relations*, *World Development*, *Development Policy Review*, *Studies in Comparative International Development*, *New Political Economy*, *China International Strategy Review*, and *The Oxford Handbook of Industrial Policy*. At Peking University, she teaches *International Development Policy* (undergraduate) and *China and Global Development* (graduate).

Muyang holds a Ph.D. from the University of Washington, an M.A. from the University of California, Berkeley, and dual bachelor's degrees from Peking University and Waseda University. She was a research fellow at the Global Development Policy Center of Boston University a visiting scholar at Japan's National Graduate Institute for Policy Studies.



2. 初晓波 (CHU Xiaobo)

男，1971年12月生于山东文登，法学博士，北京大学国际关系学院教授、亚非研究所所长，北京大学日本研究中心主任。主要研究领域为东北亚政治外交、危机管理研究，先后发表独著、合著、译著多部，以及62篇中、英、日文论文。

Dr. Chu Xiaobo was born on December 8th 1971 in Shandong Province, China. He is a professor of the School of International Studies, Peking University and Director of Institute of Afro-Asian Studies. He has been a standing trustee of the Chinese Association for Japanese Studies since 2010. Dr. Chu's scholarly interests cover East Asian studies and crisis management studies. He has published numerous works, and about 60 papers in these fields.



3. 戴惟静 (DAI Weijing)

GUI Yongtao is Associate Dean of the School of International Studies and Associate President of the Institute of International and Strategic Studies at Peking University. His research focuses on international relations of East Asia.

His recent publications include: “Exploring the Changing Relations Between the U.S., Japan and China”(2022); “Economic Statecraft, Economic Security Policy, and New Trends in U.S. and Japan’s Policies toward China” (2021); “Japan and the U.S.-China Strategic Competition: Trade War, Technology War, and the Indo-Pacific Strategy” (2020); “Competing in the Gray Zone: A New Situation in U.S.-Japan Engagement with China” (2019); “The Politics of TPP: The Motivation and Predicament of U.S.-Japan Cooperation” (2017).

5. 李昀 (LI Yun)

6. 庞珣 (PANG Xun)

北京大学国际关系学院教授、北京大学全球风险政治分析实验室主任、美国政治学方法学会旗舰期刊 *Political Analysis* 副主编、中国民主同盟中央青年委员会主任。曾任美国普林斯顿大学政治系助理教授、清华大学社会科学学院副教授和教授、清华-卡内基全球政策研究中心中方主任、清华大学国际关系研究院副院长、美国普林斯顿大学尼豪斯全球化与治理研究中心访问研究员。主要研究领域为全球风险政治、国际组织与全球治理、贝叶斯统计、社会科学因果推断等。北京大学国际关系学士和硕士、经济学双学士，美国圣路易斯华盛顿大学政治学博士。



PANG Xun is the Boya Young Professor in the School of International Studies at Peking University, the director of PKU's Analytics Lab for Global Risk Politics, the associate editor of *Political Analysis* (the flagship journal of the Society for Political Methodology), the director of the Central Committee for Young Leaders in China Democratic League. Before joining the faculty of Peking University, Prof. Pang was Assistant Professor in the Department of Politics at Princeton University, Associate Professor and Professor in the School of Social Sciences at Tsinghua University, the co-director of the Carnegie-Tsinghua Global Policy Center, the vice dean of Tsinghua's Institute for International Relations Studies, and the visiting research scholar at the Niehaus Center for Globalization and Governance at Princeton University. Prof. PANG's research interests include theories and methods for global risk politics, international organizations and global governance, Bayesian statistics and causal inference in social sciences.

Prof. Pang received her B.A. and M.A. from Peking University and Ph.D. from Washington University in St. Louis.



7. 祁昊天 (QI Haotian)

北京大学国际关系学院国家安全学系助理教授，北京大学国际安全与和平研究中心副主任。主要研究方向包括科技与国家安全、军事战略与技术、冲突管控、美军研究、社会科学方法论。负责和参与授课包括：国家安全学导论、International Security Studies、Introduction to International Public Policy、理解世界政治、技术变迁与国家安全、政治博弈论、国际关系理论、社会研究方法等。

Qi Haotian is assistant professor at Peking University's School of International Studies, Deputy Director of Center for International Security and Peace Studies. He teaches courses on international security, IR theories, military science and game theory. His research interests cut across technological transitions & national security, military strategy & technology, conflict management, and methodologies of social sciences.



8. 秦亚青 (QIN Yaqing)

山东大学讲席教授，外交学院原院长、教授，比利时皇家学会外籍院士。曾任中国国际关系学会常务副会长、联合国名人小组研究队成员，10+3、10+1、中日韩思想库网络中国国家协调员。主要研究领域为国际关系理论和全球治理，代表性学术成果有《世界政治的关系理论》等。

Qin Yaqing, Distinguished Chair Professor at Shandong University, Former President of China Foreign Affairs University, and Associate Member of Belgian Royal Academy. He worked as member of the resource team of the UN High Level Panel, country coordinator respectively for the Network of East Asian Think Tanks (NEAT), the Network of ASEAN-China Think Tanks (NACT), and the Network of China-Japan-Korea Think Tanks.

His major academic interests are International Relations theory and global governance. His recent publications include *A Relational Theory of World Politics* (Cambridge) and *Globalizing IR Theory: Critical Engagement* (Routledge).





9. 孙庆伟 (SUN Qingwei)

北京大学党委常委、副校长兼秘书长，历史学博士，北京大学考古与博物馆学院教授，主要研究方向为夏商周考古、考古学史、中国古代玉器研究。

QINGWEI SUN is Vice President of Peking University and Professor at the School of Archaeology and Museology, Peking University. He received B.A., M.A. and Ph.D. in History from Peking University. His research mainly focuses on the archaeology of the Chinese Bronze Age, the history of archaeology, ancient Chinese jade ware and jade culture.



10. 孙岩峰 (SUN Yanfeng)

研究员，现任中国现代国际关系研究院拉美研究所副所长。长期从事拉美地区综合研究，主要研究拉美政治、安全和经济形势、中拉关系，特别是对巴西、阿根廷、委内瑞拉等南美国家长期跟踪研究，撰写大量学术文章和时政评论。

Prof. Sun Yanfeng is Deputy Director and Research Professor of the CICIR Institute of Latin American Studies, He has been engaged in the comprehensive studies on Latin America, which cover the regional politics, security and economy, Sino-Latin American relations by following the dynamics of Brazil, Argentine and Venezuela in particular. He has been involved in authoring the academic publications and contributed politics commentaries on Latin-American issues and Sino-Latinamrican relations for medias.





11. 唐士其 (TANG Shiqi)

北京大学国际关系学院院长、教授，北京大学东西方文化研究中心主任。主要研究领域包括西方政治思想史、当代西方政治哲学、比较政治学。主要著作包括《美国政府与政治》、《国家与社会的关系》、《西方政治思想史》、《全球化与地域性》、《理性主义的政治学》等。

Tang Shiqi, Dean and professor of the School of International Studies, director of the Center of Eastern-western Culture Studies, Peking University. Researching areas are history of Western political thought, contemporary Western political philosophy, and comparative politics. Main publishes include *American Government, State and Society, A History of Western Political Thoughts, Globalization and Territoriality, Politics of Rationalism: Its Origin, Crisis and Sublation, etc.*



12. 王正毅 (WANG Zhengyi)

北京大学博雅特聘教授，北京大学社会科学学部副主任、国际关系学院学术委员会主任及国际政治经济学系主任，教育部“长江学者”特聘教授。主要从事国际政治经济学理论、东亚地区合作、世界体系与中国等方面的教学与研究。代表性著作包括《世界体系论与中国》（商务印书馆 2000 年）、《世界体系与国家兴衰》（北京大学出版社 2006 年）、《边缘地带发展论：世界体系与东南亚的发展（第二版）》（上海人民出版社 2018 年）、《国际政治经济学通论（第二版）》（北京大学出版社 2022 年）。

WANG Zhengyi, Distinguished professor (Yangtze River scholar), deputy director of Office of Humanities and Social Sciences of Peking University. Director of Academic Committee of School of International Studies, and chair of Department of International Political Economy, Peking University, China.



As one of founders of IPE in China, he has focused on international political economy, especially on Asian Pacific regionalism and political economy of transition and development in China. He has published a series of books and articles in both Chinese and English, including *General Theory of International Political Economy*(2010, 2022), *Periphery Development: World System and Southeast Asia*(2018), “The Rise of China: The Sustained Development of the World System or the End of It?”(2013), “Contending East Asian Regional Identity: market-led, institutions or social reconstruction?”(2010), “Researching International Relations in China”(2010), “Conceptualizing Economic Security and Governance: China confronts globalization”(2004), “Inherit or transfer: A Dilemma in Reconstructing Chinese Social Reality”(1998).



13. 徐沁仪 (XU Qinyi)

北京大学国际关系学院助理教授，剑桥大学博士。曾任剑桥大学韧性与可持续发展中心（CRSD）和剑桥大学环境，能源与自然资源治理中心（C-EENRG）研究员。主要研究领域为非传统安全（环境与能源安全等），全球环境与气候治理，国际政治经济学；内容上侧重于对气候治理中的安全与风险、国家角色冲突、气候领导权、环境气候与贸易政治等方面的研究。多篇论文发表于SCI/SSCI刊物。



Dr. Qinyi Xu is Assistant Professor at the School of International Studies, Peking University. Before joining Peking University, Dr. Qinyi Xu served as Research Associate at the Centre for Resilience and Sustainable Development (CRSD) and Researcher at the Cambridge Centre for Environment, Energy and Natural Resource Governance (C-EENRG), University of Cambridge. Her research spans global climate governance, environmental & energy security and economics to international political economy (global trade politics and governance). She has published widely in SCI/SSCI journals, with a special focus on security and risks, role conflicts, climate leadership and trade-environment nexus in climate governance.

14. 于铁军 (YU Tiejun)

现任北京大学国际关系学院教授、北京大学国际战略研究院院长，《中国国际战略评论》（中英文版）执行主编、“北京大学国际战略研究丛书”副主编和“北京大学战争与战略研究丛书”执行主编。在北京大学获得法学学士（1990）、硕士（1997）和博士学位（2000），曾先后在东京大学、斯坦福大学、哈佛大学和麻省理工学院留学或做访问学者。教学和研究领域为东亚国际关系、国际安全与战略、国际关系史和国际政治理论。曾获北京大学优秀教学奖、本科生科研训练“优秀指导教师奖”等。



Yu Tiejun is a professor at Peking University's School of International Studies and president of the university's Institute of International and Strategic Studies. He was a Fulbright visiting scholar at MIT's security studies program (2018–19) and visiting scholar at Stanford University and Harvard University (2005–06) and studied at the University of Tokyo (1998–2000). Yu is executive editor in chief of *China International Strategy Review* and has written extensively on international security, East Asian international relations, and China's foreign and defense policy. He was awarded Peking University's Excellent Teaching Award and Distinguished Research Award in 2010 and 2017, respectively. Yu received his BA, MA, and PhD from Peking University.



15. 张海滨 (ZHANG Haibin)

北京大学国际关系学院副院长、教授，北京大学国际组织研究中心主任，北京大学碳中和研究院副院长，北京大学全球健康发展研究院副院长。主要从事国际组织与全球治理、国际环境和气候政治、中国环境外交等研究。兼任中国国家气候变化专家委员会委员、中国商务部贸易与环境专家组成员、中国联合国协会常务理事、中国文化与旅游部国家文化和旅游公共服务专家委员会委员、德国外交部气候与安全专家组成员、中华预防医学会全球卫生委员会常务委员。



Dr. ZHANG Haibin is the Vice Dean and Professor of the School of International Studies, Director of the Center for International Organization Studies, Peking University(PKU), Vice Dean of the Institute of Carbon Neutrality, PKU, and the Vice Dean of the Institute of Global Health and Development, PKU. His major research areas are international organizations, international climate politics and China's environmental diplomacy. He is the member of China's National Expert Panel on Climate Change, adviser to the Ministry of Commerce, China, on trade and environment issues; member of the Board of United Nations Association of China; adviser to the Ministry of Culture and Tourism China, on public service issues; adviser to the Ministry of Foreign Affairs, Germany, on climate and security issues; and executive member of Global Health Council of Chinese Preventive Medicine Association.

16. 张宇燕 (ZHANG Yuyan)

中国社会科学院世界经济与政治研究所所长，中国社会科学院学部委员，中国社会科学院国家全球战略智库首席专家，中国社会科学院大学教授，全国政协外事委员会委员，外交部国际经济金融咨询委员会委员，财政部国际财经研究专家工作室专家总牵头人，商务部经贸政策咨询委员会委员，中国世界经济学会会长。长期从事制度经济学和国际政治经济学研究，出版《经济发展与制度选择》（1992）、《国际经济政治学》（2008）、《美国行为的根源》（2015）、《中国和平发展道路》（2017）等著作。



Professor ZHANG Yuyan is Director of Institute of World Economics and Politics (IWEP), Chinese Academy of Social Sciences (CASS), CASS Member, Chief Expert of National Institute for Global Strategy, CASS, Professor of University of Chinese Academy of Social Sciences, Member of the Committee of Foreign Affairs of the National Committee of the Chinese People's Political Consultative Conference (CPPCC), Member of the International Economics and Finance Advisory Group of the Ministry of Foreign Affairs of China, General coordinator of the International Finance



and Economic task force of the Ministry of Finance of China, Expert of Advisory Committee for Economic & Trade Policy of the Ministry of Commerce of China, President of China Society of World Economy . He authored *Economic Development and the Choice of Institutions* (1992), *International Economic Politics*(2008), *The Sources of American Conduct*(2015) and *The Path of China's Peaceful Development* (2017), etc.

17. 朱锋 (ZHU Feng)

朱锋教授现为南京大学国际关系学院执行院长、南京大学中国南海研究协同创新中心执行主任。朱锋教授的研究专长为中美关系、东亚地区安全和亚太海上安全。朱锋教授现任中国国际关系学会副会长和中华日本学会副会长。朱锋教授近期的代表性学术专著有：*China's Ascent: Power, Security and International Politics* (co-edited with Prof. Robert S. Professor Zhu Feng is Executive Dean of School of International Studies of Nanjing University. He is also serving as Executive Director of Center for Collaborative Studies of the South China Sea at Nanjing University. Prof. Zhu is specializing in the Asia-Pacific regional security, and very prolific on the maritime security affairs, China-U.S.-Japan relations, and North Korean nuclear proliferation issue. His book *China's Ascent: Power, Security and International Politics* (co-edited with Prof. Robert S. Ross, Cornell University Press, 2008) is widely cited in the studies of China's foreign policy. Dr. Zhu's recent book is *America-China and Struggle for the World Order* (co-edited with Prof. G. John Ikenberry and Prof. Wang Jisi, Palgrave/MacMillan, 2015), and *the Sea-Power in the 21st Century: Historical Lessons and China Challenge* (Beijing, Shijie Zhishi Press, 2016), *Re-examination of 2016 Arbitrator Ruling over the South China Sea Disputes* (co-edited with Prof. Yu Mincai, Beijing: World Knowledge Press, 2018).

1. AKIO Takahara (高原明生)

Akio Takahara is Professor of Contemporary Chinese Politics at the Graduate School of Law and Politics and the Graduate School of Public Policy (GraSPP) at The University of Tokyo. He received his DPhil in 1988 from Sussex University, and later spent several years as Visiting Scholar at the Consulate-General of Japan in Hong Kong, the Japanese Embassy in Beijing, Harvard University, Peking University, the Mercator Institute for China Studies, and the Australian National University. Before joining The University of Tokyo, he taught at J. F. Oberlin University and Rikkyo University. He served as President of the Japan Association for Asian Studies, and as Secretary General of the New Japan-China Friendship 21st Century Committee. Akio was Dean of GraSPP from 2018 to 2020. He currently serves as Senior Adjunct Fellow of the Japan Institute of International Affairs, Distinguished Research Fellow of the Japan Forum on International Relations, and Director of the Japan International Cooperation Agency (JICA) Ogata Sadako Research Institute for Peace and Development. His publications in English include *The Politics of Wage Policy in Post-Revolutionary China*, (Macmillan, 1992), *Japan-China Relations in the Modern Era*, (co-authored, Routledge, 2017), and “Introduction to the special issue on the comparative study of Asian countries’ bilateral relations with China”, *Journal of Contemporary East Asia Studies*, Volume 10, Issue 2 (2021).



高原明生，当代中国政治学教授，任职于东京大学政法研究生院和公共政策研究生院（GraSPP）。1988年在苏塞克斯大学获博士学位，随后数年在日本驻香港总领事馆、日本驻北京大使馆、哈佛大学、北京大学、墨卡托中国研究所和澳大利亚国立大学担任访问学者。入职东京大学之前，曾在日本樱美林大学和立教大学任教。曾担任日本亚洲研究协会主席、新日中友好 21 世纪委员会秘书长。2018 至 2020 年，高原明生教授担任东京大学政法研究生院和公共政策研究生院院长。目前担任日本国际事务研究所的高级兼职研究员、日本国际关系论坛的杰出研究员，以及日本国际协力机构(JICA)绪方贞子和平与发展研究所主任。出版的英文著作包括《革命后中国的工资政策政治》（1992 年）、《现代日中关系》（合著，2017 年）和《亚洲国家与中国双边关系比较研究专刊导言》，《当代东亚研究杂志》（2021 年第 10 卷第 2 期）。



2. Arne Westad (文安立)

Odd Arne Westad is a scholar of modern international and global history, with a specialization in the history of eastern Asia since the 18th century. Originally from Ålesund on the Norwegian coast, he studied history, philosophy, and modern languages in Oslo before doing a graduate degree in US/international history at the University of North Carolina at Chapel Hill. Westad has published 16 books, most of which deal with twentieth century Asian and global history. In the first part of his career, Westad was mainly preoccupied with the history of the Cold War, China-Russia relations, and the history of the Chinese civil war and the Chinese Communist Party. He published two monographs, *Cold War and Revolution*, which deals with US and Soviet intervention in the Chinese Civil War in 1944-1946, and *Decisive Encounters*, which is a general history of the Chinese civil war and the Communist victory in the period from 1946 to 1950. He also edited several books on Sino- Soviet and Cold War history topics. Since the mid-2000s, Westad has been concerned with more general aspects of post-colonial and global history, as well as the modern history of China. The three key works from this period are *The Global Cold War*, which argues for ways of understanding the Soviet-American conflict in light of late- and post-colonial change in Asia, Africa, and the Caribbean; *Restless Empire*, which discusses broad trends in China's international history since 1750; and *The Cold War: A World History*, which summarizes the origins, conduct, and results of the conflict on a global scale. Today Westad is mainly interested in researching histories of empire and imperialism, first and foremost in Asia, but also world-wide. He is also trying to figure out how China's late twentieth century economic reforms came into being and how their outcomes changed the global economy.



Westad joined the faculty at Yale after teaching at the London School of Economics (LSE), where he was School Professor of International History, and at Harvard University, where he was the S.T. Lee Professor of US-Asia Relations. At Yale, he teaches in the History Department and at the Jackson Institute for Global Affairs, is an adviser at Davenport College, and serves as director of International Security Studies. Westad is a fellow of the British Academy and of several other national academies, a visiting professor at Peking University, and a research associate of the Harvard Fairbank Center.

文安立，历史与全球事务教授，现代国际和全球历史学者，研究领域为 18 世纪以来的东亚历史。来自挪威海岸的奥勒松，在挪威奥斯陆学习历史、哲学和现代语言，后在北卡罗来纳大学教堂山分校攻读美国/国际历史研究生学位。已出版 16 本书，其中大部分是关于二十世纪亚洲和全球历史。文安立教授职业生涯的前半段主要关注冷战史、中俄关系，以及中国内战和中国共产党的历史。出版两部专著：《冷战与革命》，涉及美国和苏联对 1944 至 1946 年中国内战的干预；《决战》，是一部关于 1946 至 1950 年期间中国内战和共产党胜利的通史。文安立教授还编写了一些关于中苏和冷战史主题的书籍。自 2000 年以来，文安立



教授一直关注后殖民主义和全球历史，以及中国现代史等领域。这一时期的三部重要作品是《全球冷战》，该书根据亚洲、非洲和加勒比地区的后殖民时期的变化，论证了理解苏美冲突的方法；《不安的帝国》讨论了 1750 年以来中国国际史中蕴含的大趋势；《冷战：世界史》总结了全球范围内冲突的起源、行为和结果。当前主要感兴趣的领域是帝国和帝国主义的历史，从亚洲到全球范围；还研究了中国 20 世纪末的经济改革是如何产生的，其结果如何改变全球经济。

文安立教授在入职耶鲁大学前，曾任伦敦政经学院（LSE）国际历史学院教授、哈佛大学美国-亚洲关系教授。在耶鲁大学历史系、杰克逊全球事务研究所任教，并担任达文波特学院顾问、国际安全研究主任。同时担任英国研究院的研究员、北京大学访问教授，以及哈佛大学费正清研究中心的研究助理。

3. Chikako Kawakatsu Ueki（植木千可子）

Dr. Chikako Kawakatsu Ueki is Professor of International Relations at the Graduate School of Asia-Pacific Studies (GSAPS), Waseda University. Her areas of expertise include International Relations and Security in East Asia with a special focus on U.S.-Japan-China relations. She has written extensively on issues concerning threat perception in a unipolar world, transformation of international relations after the Cold War, and issues relating to security problems in East Asia. At Waseda University, she leads a program on Security Studies at the Institute for Asia-Pacific Studies (WIASP). Her publications include: *War Studies for Peace* (2015); *The “Long Peace” in Northeast Asia: War Avoided* (2012); and *The U.S.-Japan Security Alliance: Regional Multilateralism* (2011). Prior to joining GSAPS, Dr. Ueki was Senior Research Fellow at the National Institute for Defense Studies, Japan Ministry of Defense; Visiting Scholar at Peking University; and Staff Writer for *Asahi Shimbun*. She served as a member of the Prime Minister’s Council on Security and Defense Capabilities (2009). She holds a Ph.D. in Political Science from Massachusetts Institute of Technology (MIT), and M.A. in International Relations and B.A. in French Studies from Sophia University.

4. Jack Snyder (杰克·斯奈德)

Jack Snyder is the Robert and Renée Belfer Professor of International Relations in the political science department and the Saltzman Institute of War and Peace Studies at Columbia University. A Fellow of the American Academy of Arts and Sciences, his books include *Human Rights for Pragmatists: Social Power in Modern Times* (Princeton University Press, 2022); *Human Rights Futures* (co-edited with Stephen Hopgood and Leslie Vinjamuri, Cambridge University Press, 2017); *Ranking the World: Grading States as a Tool of Global Governance* (co-editor with Alexander Cooley, Cambridge University Press, 2015); *From Voting to Violence: Democratization and Nationalist Conflict* (Norton Books, 2000; Chinese edition, Shanghai Press, 2017); *Myths of Empire: Domestic Politics and International Ambition* (Cornell University Press, 1991; Chinese edition, 2007). 5. Mathieu Duchâtel (杜懋修)

Dr. Mathieu Duchâtel is Director of the Asia Program at Institut Montaigne since 2019. Before joining the Institute he was Senior Policy Fellow and Deputy Director of the Asia and China Program at the European Council of Foreign Relations (2015-2018), Senior Researcher and the Representative in Beijing of the Stockholm International Peace Research Institute (2011-2015), Research Fellow with Asia Centre in Paris (2007-2011) and Associate Researcher based in Taipei with Asia Centre (2004-2007). He has spent a total of nine years in Shanghai (Fudan University), Taipei (National Chengchi University) and Beijing and has been visiting scholar at the School of International Studies of Peking University in 2011/2012 and the Japan Institute of International Affairs in 2015, and the Institute of National Defense and Security Research in Taipei in September 2020. He holds a Ph.D in political science from the Institute of Political Studies (Sciences Po, Paris).



For Institut Montaigne, he recently authored *Semiconductors in Europe: the Return of Industrial Policy* (March 2022), *Technology Transfers: the Case for an EU-Japan-US Cooperation Framework* (March 2022) *The Weak Links in China's Drive for Semiconductors* (January 2021), *Fighting COVID-19: East Asian Responses to the Pandemic* (May 2020, with François Godement and Viviana Zhu), and *Europe and 5G: the Huawei Case* (May 2019, with François Godement).

6. M. Taylor Fravel (傅泰林)

M. Taylor Fravel is the Arthur and Ruth Sloan Professor of Political Science and Director of the Security Studies Program at the Massachusetts Institute of Technology. Taylor studies international relations, with a focus on international security, China, and East Asia. His books include *Strong Borders, Secure Nation: Cooperation and Conflict in China's Territorial Disputes*, (Princeton University Press, 2008) and *Active Defense: China's Military Strategy Since 1949* (Princeton University Press, 2019). His other publications have appeared in *International Security*, *Foreign Affairs*, *Security Studies*, *International Studies Review*, *The China Quarterly*, *The Washington Quarterly*, *Journal of Strategic Studies*, *Armed Forces & Society*, *Current History*, *Asian Survey*, *Asian Security*, *China Leadership Monitor*, and *Contemporary Southeast Asia*. Taylor is a graduate of Middlebury College and Stanford University, where he received his PhD. He also has graduate degrees from the London School of Economics and Oxford University, where he was a Rhodes Scholar. In 2016, he was named an Andrew Carnegie Fellow by the Carnegie Corporation. Taylor has been a member of the board of directors of the National Committee on U.S.-China Relations and serves as the Principal Investigator for the Maritime Awareness Project.

7. Mary Kaldor (玛丽·卡尔多)

Mary Kaldor is Professor Emeritus of Global Governance at the London School of Economics and Political Sciences. She has pioneered the concepts of new wars and global civil society. Kaldor is the author of many books and articles including “New and Old Wars: Organised Violence in a Global Era” (3rd edition, 2012), “International Law and New Wars” (with Christine Chinkin, 2017) and “Global Security Cultures” (2018). Additionally to her academic engagements, she was co-chair of the Helsinki Citizens Assembly, a member of the International Independent Commission on Kosovo and convenor of the Human Security Study Group, which reported to Secretary General of NATO, Javier Solana.

8. Øystein Tunsjø (奥斯汀·腾斯强)

Øystein Tunsjø is Professor and Head of the Security in Asia Program at the Norwegian Institute for Defence Studies at the Norwegian Defence University College. Tunsjø is author of *The Return of Bipolarity in World Politics: China, the United States and Geostructural Realism*, (Columbia University Press, 2018); *Security and Profits in China’s Energy Policy: Hedging Against Risk* (Columbia University Press, 2013) and *US Taiwan Policy: Constructing the Triangle* (London: Routledge, 2008). Tunsjø is co-editor with Robert S. Ross and Wang Dong of *US-China Foreign Relations: Power Transition and Its Implications for Europe and Asia* (London: Routledge, 2021); co-editor with Robert S. Ross of *Strategic adjustment and the Rise of China: Power and Politics in East Asia* (Ithaca: Cornell University Press, 2017); co-editor with Robert S. Ross and Peter Dutton of *Twenty First Century Seapower: Cooperation and Conflict at Sea* (London: Routledge, 2012, translated to Chinese, 21 Shiji Haiyang Daguo: Haishang Hezuo yu Zhongtu Guanli, by Shehui Kexue Wenxian Zhubanshe, Beijing, 2014) and co-editor with Robert Ross and Zhang Tuosheng of *US-China-EU Relations: Managing a New World Order* (London: Routledge, 2010, translated to Chinese, Zhong Mei Ou Guanxi: Goujian Xin





de Shijie Zhixu by the World Affairs Press, Beijing, 2012). Tunsjø has published articles in journals such as China International Strategy Review, The National Interests, Survival, International Relations, Cooperation and Conflict and World Economy and Politics (in Chinese) and contributed with book chapters to several edited volumes. Tunsjø holds a PhD in International Relations from the University of Wales, Aberystwyth, 2006, a Cand Philol in History from the University of Oslo, an MSc from the London School of Economics, 2002 and a MA from Griffith University, Australia, 2000. Tunsjø was a visiting Fulbright scholar at the Fairbank Center for Chinese Studies, Harvard University, during spring term of 2010 and will be a visiting Fulbright scholar at MIT during spring term of 2023.

9. ROBERT S. ROSS (陆伯彬)

Robert S. Ross is Professor of Political Science at Boston College and Associate, John King Fairbank Center for Chinese Studies, Harvard University. In 1989 Professor Ross was a Guest Scholar at the Brookings Institution in Washington, D.C. In 1994-1995 he was Fulbright Professor, Chinese Foreign Affairs College; in 2003 he was Visiting Senior Fellow, Institute of International Strategic Studies, Qinghua University; and in 2014 he was Visiting Scholar, School of International Relations, Peking University. In 2009 he was Visiting Scholar, Institute for Strategy, Royal Danish Defence College.



Professor Ross's research focuses on Chinese security policy, Chinese use of force, and East Asian security. His recent publications include China in the Era of Xi Jinping: Domestic and Foreign Policy Challenges, Chinese Security Policy: Structure, Power,



and Politics, *China's Ascent: Power, Security, and the Future of International Politics*. His other major works include *Great Wall and Empty Fortress: China's Search for Security* and *Negotiating Cooperation: U.S.-China Relations, 1969-1989*. Professor Ross is the author of articles in *World Politics*, *China Quarterly*, *International Security*, *Journal of Contemporary China*, *Security Studies*, *European Journal of International Relations*, *Foreign Affairs*, *Foreign Policy*, *National Interest*, and *Asian Survey*. His works have been translated in China, Taiwan, Korea, Japan, and various European countries.

Professor Ross has received research fellowships from the University of Washington and Columbia University. He has received research grants from the Social Science Research Council, John D. and Catherine T. MacArthur Foundation, Ford Foundation, Smith-Richardson Foundation, International Research and Exchanges Board (IREX), Asia Foundation, and United States Institute of Peace.

Professor Ross has testified before the U.S. Congress and the Defense Policy Board Advisory Committee and he has consulted to U.S. government agencies. He is a member of the Council on Foreign Relations and he is a member of the executive committee of the John King Fairbank Center for Chinese Studies, Harvard University. He is a founding member and former board member of the United States Committee of the Council for Security Cooperation in the Asia-Pacific.

陆伯彬是波士顿学院政治学教授、哈佛大学费正清中国研究中心研究员。1989年，陆伯彬教授在布鲁金斯学会（华盛顿特区）担任客座学者；1994年至1995年，作为富布赖特学者在中国外交学院访学；2003年，任清华大学国际战略研究所客座高级研究员；2014年，任北京大学国际关系学院访问学者；2009年，任丹麦皇家国防学院战略研究所访问学者。

陆伯彬教授的研究领域是中国安全政策、中国的武力使用和东亚安全。他近年来的著作有《习近平时代的中国：内政和外交政策挑战》、《中国的安全政策：结构、权力和政治》、《中国的崛起：权力、安全和国际政治的未来》。其他主要作品包括《长城与空城计：中国寻求安全的战略》、《风云变幻的美中关系（1969~1989）：在谈判中合作》。罗斯教授曾在《世界政治》、《中国季刊》、《国际安全》、《当代中国杂志》、《安全研究》、《欧洲国际关系杂志》、《外交事务》、《外交政策》、《国家利益》、《亚洲调查》等期刊上发表论文。陆伯彬教授的作品被翻译到中国、中国台湾、韩国、日本和欧洲各国。

陆伯彬教授曾获华盛顿大学和哥伦比亚大学的研究奖学金。曾获社会科学委员会、麦克阿瑟基金会、福特基金会、史密斯·理查森基金会、国际研究与交流委员会、亚洲基金会、美国和平研究所的研究资助。

陆伯彬教授曾在美国国会和国防政策委员会咨询委员会作证，并为美国政府机构提供咨询。他是外交关系委员会的成员，也是哈佛大学费正清中国研究中心执行委员会委员。他还是亚太安全合作理事会美国委员会的创始成员和前董事会成员。



10. William C. Wohlforth (威廉·沃尔弗斯)

William C. Wohlforth is a professor of international relations at the Government Department since 2000. He teaches and conducts research on international relations, with an emphasis on international security and foreign policy. Before coming to Hanover, he taught at Princeton and Georgetown.



He is the author or editor of nine books and some 60 articles and chapters on topics ranging from the Cold War to contemporary U.S. grand strategy. He teaches courses in international politics, Russian foreign policy, leadership and grand strategy, violence & security and decision-making.

At Dartmouth, he has served as chair of the Government Department, on the Committee Advisory to the President, the Committee on Instruction, and on many College level search committees. Beyond Dartmouth, he has held fellowships at the Institute of Strategic Studies at Yale, the Center for International Security and Cooperation at Stanford, and the Hoover Institution. For six years he served as associate editor and then editor-in-chief of the journal *Security Studies*.

A lot of his work is relevant to policy. He participates in a working group sponsored by the National Intelligence Council that is studying strategic responses to U.S. unipolarity. The work of his team has figured in several NIC reports, including most recently *Global Trends 2030*. He has served as a consultant to the Strategic Assessment Group and the National Bureau of Asian Research. He routinely lectures and conducts seminars with policy-makers, including, in recent years, the National Defense University, Naval War College, Army War College, George C. Marshall Center for Security Studies, and defense and foreign policy institutes in Germany, Canada, Portugal, Norway, Russia, and the United Kingdom.

威廉·沃尔弗斯教授自 2000 年以来一直在达特茅斯学院政府管理系任教，从事国际关系方面的教学和研究，重点领域为国际安全和外交政策。在此之前，他还曾在普林斯顿大学和乔治城大学任教。

威廉·沃尔弗斯著有 9 本著作、约 60 篇文章和专著章节，主题范围涵盖从冷战到当代美国大战略。他开设的课程包括国际政治、俄罗斯外交政策、领导力和大战略、暴力、安全与决策。

他曾任达特茅斯学院政府管理系主任，并担任校长咨询委员会、教学委员会和多个学院级别学术委员会委员。他也曾在耶鲁大学战略研究所、斯坦福大学国际安全与合作中心和胡佛研究所担任研究员；六年来，先后担任《安全研究》杂志的副主编和主编。

他的研究工作多与政策相关。他参加了一个由国家情报委员会赞助的工作组，研究对美国单极化的战略反应。该工作组的研究成果曾出现在国家情报委员会的几份报告中，包括最近的《2030 年全球趋势》。他曾担任战略评估小组和国家亚洲研究局的顾问。他定期为政策制定者开办讲座和研讨会，包括近年来在国防大学、海军战争学院、陆军战争学院、乔治·马歇尔安全研究中心、以及德国、加拿大、葡萄牙、挪威、俄罗斯和英国的国防和外交政策研究所。



11. William H. Overholt (威廉·奥弗霍尔特)

Dr. Overholt has been Senior Research Fellow at Harvard since 2008. From 2013-2015 he was also President of the Fung Global Institute in Hong Kong. From 2002-2008 he was Asia Policy Distinguished Chair at RAND and Director of RAND's Center for Asia Pacific Policy. He served as Asia regional Head of Strategy and Economics for Nomura from 1998 to 2001. Before that, he was Managing Director and regional Head of Research at Bank Boston Singapore. During 18 years at Bankers Trust, he managed a country risk team in New York from 1980 to 1984 and then served as regional strategist in Hong Kong. At Hudson Institute, 1971-1979, he directed planning studies for the U.S. Department of State, National Security Council, National Aeronautics and Space Administration, and Council on International Economic Policy.



Dr. Overholt has advised several top Asian and African leaders at turning points in their countries' histories.

Dr. Overholt has published nine books, including *China's Crisis of Success* (2018); *North Korea: Peace? Nuclear War?* (2019); *Renminbi Rising: The Emergence of a New Global Monetary System* (2016); *Asia, America and the Transformation of Geopolitics* (2008); *The Rise of China* (1993); *Political Risk* (1982); and (with William Ascher) *Strategic Planning and Forecasting* (1983). He is principal co-author of: *Asia's Nuclear Future* (1976) and *The Future of Brazil* (1978). With Zbigniew Brzezinski, he founded the semi-annual *Global Assessment* in 1976 and edited it until 1988.

Dr. Overholt received his B.A. from Harvard and his M.Phil. and Ph.D. from Yale.

奥弗霍尔特博士自 2008 年起担任哈佛大学高级研究员，2013 年至 2015 年同时担任香港冯氏全球研究所所长。2002 年至 2008 年，担任兰德公司亚洲政策特聘主席和兰德公司亚太政策中心主任。1998 年至 2001 年，担任野村证券公司亚洲地区战略与经济主管。在此之前，他曾任新加坡波士顿银行总经理兼区域研究主管。奥弗霍尔特博士曾在美国信孚银行工作 18 年，其间他于 1980 年至 1984 年在纽约管理一个国家风险团队，继而在香港担任区域战略师。1971 年至 1979 年，他就职于哈德逊研究所，指导为美国国务院、国家安全委员会、国家航空航天局和国际经济政策委员会所作的规划研究。

奥弗霍尔特博士曾在多个亚洲和非洲国家的历史转折点为其最高领导人提供咨询。

奥弗霍尔特博士发表了九部著作，包括《中国成功的危机》(2018)、《朝鲜：和平？核战争？》(2019)、《人民币升值：新全球货币体系的出现》(2016 年)、《亚洲、美国和地缘政治的转型》(2008)、《中国的崛起》(1993)、《政治风险》(1982)、《战略规划和预测》(与威廉·阿舍尔合著，1983)。他还是以下著作的主要合著者：《亚洲的核未来》(1976)、《巴西的未来》(1978)。1976 年，奥弗霍尔特博士与兹比格涅夫·布热津斯基共同创办了《全球评估》杂志(半年刊)，并一直担任该杂志的编辑直至 1988 年。

奥弗霍尔特博士获哈佛大学学士学位、耶鲁大学哲学硕士和博士学位。
